College of Agreement Initiation: LIM College

Sending High School: Wayne Township Public Schools

Program Specifics: Fashion Marketing; full year course

Receiving College: LIM College

Programs: Transferable credits will be applicable to any LIM College degree program.

Articulation Agreement

This articulation agreement is designed for graduates who achieved a cumulative B average (80 or higher) at Wayne Township Public School's fashion discipline specific program, will receive the following transferable credits:

- ***ELEC 9999: General Elective; 3 credits***

Additional Details:

- Applicant must graduate from their home high school.
- Applicant must be accepted to LIM College as a matriculated student.
- Upon enrollment, student should inform Admissions Counselor that they participated in their high school's fashion specific program.
- Students must meet the admissions requirements for the academic year in which they are admitted. Please refer to the college catalog for complete admissions and program requirements.
- Students are required to submit an official transcript from their respective Wayne Township Public School in order to complete the transfer of applicable credit.
- LIM College and Wayne Township Public Schools shall review and update the Articulation Agreement as necessitated by curriculum changes by either party.

Marketing & Recruitment:

LIM College and Wayne Township Public Schools will work together to promote this Agreement to the participants which may include on-site events (classroom presentation and/or guidance visit) and distribution of marketing materials. The parties may utilize each other's trademarks in connection with promoting the Agreement, provided the other party pre-approves such use; neither party shall gain any right, title or interest in any name or trademark of the other party.

Termination and Modification

This Agreement is effective July 8, 2021 and shall remain in effect for five years. Thereafter, this Agreement may be extended via a writing signed by both parties sixty (60) days prior to the end of the current term. In addition, either party may terminate this Agreement for any reason, or no reason, by providing thirty (30) days written notice to the other party. Should this Agreement be terminated, students enrolled in the Program will be afforded the opportunity to complete the semester or program.
