**Application Instructions**

LIM College has a rolling admissions policy. You may apply at any time up to the beginning of the term until all openings are filled, although we strongly suggest applying as soon as possible.

Students who are sure that LIM College is their top choice are encouraged to apply for Early Action. The LIM College Early Action form can be found on our website along with detailed instructions and deadline information. This form must be submitted with your application in order for you to be eligible.

Once all application materials have been submitted, students applying for the fall semester will be notified of a decision within six weeks beginning December 15. When all application materials have been submitted for the spring semester, you will be notified within three to four weeks. Upon acceptance, a \$400 deposit secures your place, \$100 of which is nonrefundable. See the catalog for our Refund Policy. All candidates filing for financial aid must file the FAFSA #007466.

**Please print or type. Before being considered for admission, each applicant must submit:**

- The completed application for admission
  - \$40 nonrefundable application fee
  - Official transcripts from all high schools and colleges attended
  - Officially sent SAT or ACT Scores from the College Board or ACT:

 ACT Code: 4807  
 Scores are not required for transfer students who have completed at least 30 college credits, or who are 25 years of age or older
  - Two letters of recommendation
  - Required essay: See back of application for essay options.
  - Once all of your application materials have been received, you may be contacted if an interview is required. In addition, students who desire an on-campus interview to supplement their application may do so by request.
  - LIM College recommends that every student submit an activity sheet and/or resume. A suggested format can be found on our website.
  - International student requirements:
    - Telephone or on-campus interview
    - Submit TOEFL or IELTS Scores (see our website for minimum requirement)
    - Use World Education Service (WES) or another LIM College approved service to translate and evaluate all high school and/or college transcripts.
- LIM College reserves the right to request additional documentation and/or translation of materials.
