## 2025-2026 Identity Statement (V4)

Options A – Notary

- 1) The below (page 3) notarized Identity Statement (To Be Signed before a Notary)
- 2) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport.

Options B – Video call with School (as applicable)

- 1) Present an unexpired, valid, government-issued photo identification by appearing on a video call to an institutionally authorized individual who will review the identification.
- 2) The institution must retain a copy—electronic or hardcopy—of the identification document, including the date it was presented and the name of the authorized representative who reviewed it. This requirement can be met by capturing a screenshot of the video call, provided the identification details are legible.

## **Identity Statement**

(To Be Signed at the Institution)

The student must appear in person at **LIM College** to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student's ID.
