Instructions: This form must be printed and signed by the student’s sponsor(s) of financial support. Once signed, the student must upload this affidavit and proof of financial funding as a PDF or JPG file with the DS-2019 application. If a student has more than one sponsor, each sponsor must provide a copy of the signed affidavit below.

Message to the sponsor: Before signing the affidavit, you must understand that you are making a financial commitment to the student that should not be broken. Promise only the amount of money you are able to give. Fill this form out completely in English. Provide the student with the documentary evidence of support explained below that proves you are financially capable of providing this cash support for each semester of the student’s undergraduate or graduate program of study at LIM College. Estimated expenses for all programs of study can be found in LIM College’s DS-2019 Application.

Bank Letter: The bank letter must be issued within 6 months of the start date of the academic term at LIM College. The bank letter must be on official bank letterhead dated and stamped or signed by a bank representative. The letter must be in English or accompanied with an official translation. The letter must contain: ● the account holder’s name ● account number ● type of account (checking or savings) ● current balance in US Dollars.

Bank statement: The bank statement must be issued within 6 months of the start date of the academic term at LIM College and show history of transactions (deposits and withdrawals). The bank statement must be in English or accompanied with an official translation. The bank statement must contain: ● the account holder’s name ● account number ● type of account (checking or savings) ● current balance in US Dollars.

Certificate of deposit: Certificates of time/fixed deposit must be issued within the most recent 6 months in the student’s and/or sponsor’s name with a maturity date no later than the start date of the academic term at LIM College. If the maturity date is after the semester start date or no maturity date is specified, the financial institution must specify the exact amount of funds, in US Dollars, that are liquid and can be freely withdrawn.

Approved educational loan: Loan paperwork must show the student’s name as the loan holder, the amount of the approved loan, the date the loan takes effect, and the terms and conditions of the loan. The loan paperwork must verify that the funds can be used to support student’s living and personal expenses in the U.S.

Guaranteed Sponsorship/Scholarship Award letter: The letter must verify amount, period and circumstances of sponsorship and verifying the ability of the agency to supply those funds to support student’s living and personal expenses in the U.S. This documentation should also state the dates of disbursement of the funds to the student.

Investment Accounts: The investment account statement must be issued within 6 months of the start date of the academic term at LIM College. The investment account statement must show holdings in the student’s and/or sponsor’s name. The statements must specify the exact amount of funds, in US Dollars, that are liquid and can be freely withdrawn.
