



**Presidential Transfer
Scholarship Agreement**

LIM College and Suffolk County Community College (SCCC) agree that the following procedures shall apply to the Presidential Transfer Scholarship:

- 1) In each academic year, a total of one (1) Presidential Transfer Scholarships, covering full tuition, will be offered by LIM College to one (1) graduates of SCCC.
- 2) It is the intent of LIM College to make one award each year to one graduate from SCCC. However, LIM College reserves the right to award scholarships at its sole discretion.
- 3) The nominees for this scholarship must have a cumulative grade point average of 3.7 or better at the end of their third semester at SCCC. In addition to superior academic achievement, selection will be based on their contributions to their campus and communities through activities and service and on their student leadership experiences.
- 4) Candidates for these awards must be earning an Associate's Degree (A.S. or A.A) or an Associate of Applied Science (A.A.S.) at SCCC in any major.
- 5) Candidates must have applied to LIM College for transfer admission by March 1 in the year preceding the planned enrollment. LIM College will provide an application waiver fee for all students who are being nominated for this scholarship and who meet the GPA criteria at the time of the application.
- 6) Scholarship finalists will be nominated by the College-wide Scholarship Committee from SCCC, and up to three nominations per campus will be forwarded to LIM College by the President of SCCC. Winners will be selected by the Scholarship Committee of LIM College.
- 7) The list of all candidates for the scholarship, along with their application files, will be forwarded to LIM College. One student will be selected for the Presidential Transfer Scholarship.
- 8) Names of candidates must be submitted to the Dean of Admissions by March 30th of each year. Awards will be made on or about April 15th of each year and will be conditional pending final grades being submitted in June.
- 9) The scholarships shall be renewable annually by maintenance of a 3.0 cumulative average. Recipients are required to submit a FAFSA (Free Application for Federal Student Aid) for each year as a student of LIM College.



- 10) The scholarship recipients must attend LIM College on a full-time basis (at least 12 credits) as a matriculated student for consecutive fall and spring semesters. Scholarships apply to fall and spring semesters and are limited to the number of semesters needed to complete a degree. The Presidential Transfer Scholarships are applied to tuition only and are not applied to miscellaneous college fees and books.
- 11) Students selected for the full tuition Presidential Transfer Scholarship must transfer directly from SCCC to LIM College, attending no other college in between.
- 12) In addition to awarding full tuition scholarships LIM College will do the following:
 - a. Designate an academic advisor to work with the students transferring to LIM College;
 - b. Provide priority registration;
 - c. Designate a financial aid counselor to assist SCCC students transferring to LIM College; and
 - d. Provide on-site advising sessions on the SCCC campuses for students who are interested in the Presidential Transfer Scholarship and/or transferring to LIM College.
- 13) The continuation, terms and procedures for the Presidential Transfer Scholarship will be reviewed periodically by both institutions upon written request of either institution.
