Articulation Agreement

This articulation agreement is designed for graduates of the Southern Westchester BOCES (from one of the above listed programs) who have been accepted for admission to LIM College.

Students who have achieved a cumulative "B" average (80 or higher) in the Southern Westchester BOCES (from one of the above listed programs) will receive the following transferable credit:

- If two years are completed: ELEC 9999: General Elective; 6 credits (can fulfill two general/flex elective requirements)
- If one year is completed; ELEC 99999: General Elective; 3 credits (can fulfill one general/flex elective requirement)

Additional Details:

- Applicant must graduate from their home high school.
- Applicant must be accepted to LIM College as a matriculated student.
- Upon enrollment, applicant should inform Admissions Counselor that they participated in their BOCES program.
- Students must meet the admissions requirements for the academic year in which they are admitted. Please refer to the college catalog for complete admissions and program requirements.
- Students are required to submit an official transcript from Southern Westchester BOCES in order to complete the transfer of applicable credit.
- LIM College and Southern Westchester BOCES shall review and update the Articulation Agreement as necessitated by curriculum changes by either party.

Marketing & Recruitment:

LIM College and Southern Westchester BOCES will work together to promote this Agreement to the participants which may include on-site events (classroom presentation and/or guidance visit) and distribution of marketing materials. The parties may utilize each other's trademarks in connection with promoting the Agreement, provided the other part preapproves such use; neither party shall gain any right, title or interest in any name or trademark of the other party.

Termination and Modification

This Agreement is effective May 6, 2021 and shall remain in effect for five years. Thereafter, this Agreement may be extended via a writing signed by both parties sixty (60) days prior to the end of the current term. In addition, either party may terminate this Agreement for any reason, or no reason, by providing thirty (30) days written notice to the other party. Should this Agreement be terminated, students enrolled in the Program will be afforded the opportunity to complete the semester or program.
